

PUBLIC NOTICE OF INTENTION TO ISSUE A CERTIFICATE UNDER SECTION 19(1)(a) & 19(1)(b) OF, AND PARAGRAPH 6(1)(a) & (c) OF SCHEDULE 3 TO, THE ACQUISITION OF LAND ACT 1981

**THE PROPOSED CHILTERN RAILWAYS (BICESTER TO OXFORD IMPROVEMENTS)
ORDER**

**OPEN SPACE LAND IN THE DISTRICT OF CHERWELL, COUNTY OF OXFORDSHIRE
AND IN THE CITY OF OXFORD**

1. The Chiltern Railway Company Limited (CRCL) has applied to the Secretary of State for Transport for the above named Order under the Transport and Works Act 1992. If made, the Order will authorise the purchase of the land described in the First Schedule to this notice, and new rights over the land described in the Third Schedule to this notice which form part of an open space, as defined in the Acquisition of Land Act 1981 ("the 1981 Act"); that is, land laid out as a public garden, or used for the purposes of public recreation, or a disused burial ground.
2. The Order will be subject to Special Parliamentary Procedure unless the Secretary of State for Communities and Local Government ("the Secretary of State") gives a certificate in accordance with the provisions of section 19 of, and paragraph 6 of Schedule 3 to, the 1981 Act. The Secretary of State has been asked by CRCL to certify:
 - a) under section 19(1)(a), that he is satisfied that there has been or will be given in exchange for the land described in Part 1 of the First Schedule to this notice, other land described in the Second Schedule to this notice which is not less in area and is equally advantageous to persons, if any, entitled to rights of common or other rights and to the public, and that the exchange land has been or will be vested in the persons in whom the order land was vested, and subject to the like rights, trusts and incidents as attach to the order land; and
 - b) under section 19(1)(b), that he is satisfied that the land described in Part 2 of the First Schedule to this notice does not exceed 209 square metres in extent and that the giving in exchange of other land is unnecessary, whether in the interests of the persons, if any, entitled to rights of common or other rights or in the interests of the public; and
 - c) under paragraph 6(1)(a) of Schedule 3, that he is satisfied that the land described in Part 1 of the Third Schedule to this notice, when burdened with that right, will be no less advantageous to those persons in whom it is vested and other persons, if any, entitled to rights of common or other rights, and to the public, than it was before; and
 - d) under paragraph 6(1)(c) of Schedule 3, that he is satisfied that the land described in Part 2 of the Third Schedule to this notice affected by the rights to be acquired does not exceed 209 square metres in extent, and that the giving of other land in exchange for the rights is unnecessary, whether in the interests of persons, if any, entitled to rights of common or other rights or in the interests of the public.

3. On the open space plan referred to in paragraph 5 below, the land described in Part 1 of the First Schedule to this notice is shown coloured green, and the exchange land described in the Second Schedule to this notice is shown coloured blue.
4. The Secretary of State is required to direct CRCL to give public notice of his intention to give a certificate before he reaches a decision, to afford an opportunity for representations and objections to be made.
